- a) Accept any initial dormitory/Room allotment made to me.
- b) Change hostel/room whenever instructed by authorities to do so. I will not change /exchange room without written permission of the authorities.
- c) Obey instructions of warden/assistant warden/perfect regarding hostel matters and my conduct.
- d) While leaving hostel for a place other than college make an entry in the hostel register regarding time of leaving, destination and expected time of return to the hostel.(Normally a hostler should be back by 10 PM. Staying overnight outside is not permitted without written permission of the warden/ assistant warden /preface. The same is expected when leaving for home .
