Sub: Government Medical College, Kota – Renewal of Permission for admission of 2nd Batch of MBBS students against the increased intake i.e. from 150 to 250 for the academic session 2020-21 – reg.

Sir/Madam,

This is with reference to your application of renewal of permission for admission of 2nd batch of MBBS students against the increased intake i.e. from 150 to 250 seats at Government Medical College, Kota, submitted u/s 10A of the IMC Act, 1956 to now dissolved Board of Governors in Supersession of the Medical Council of India. It is brought to your notice that the Central Government has on 24th September 2020 notified fully the NMC Act, 2019. Section 61(2) of the NMC Act, 2019 provides as under:

"Notwithstanding the repeal of the Indian Medical Council Act, 1956, the educational standards, requirements and other provisions of the Indian Medical Council Act, 1956 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder:"

2. Accordingly your application was processed u/s 10A of the IMC Act, 1956 and the Opening of a New Higher Course of Study or Training (including Post-graduate Course of Study or Training) and Increase of Admission capacity in any Course of study or Training (including Post-graduate Courses of Study or Training) Regulations, 2000. I am directed to convey the permission of the Medical Assessment and Rating Board of the National Medical Commission for renewal of permission for admission of 2nd batch of MBBS students against the increased intake i.e. from 150 to 250 at Government Medical College, Kota u/s 28 read with section 61(2) of NMC Act, 2019 for the academic year 2020-21.


The permission is subject to:-

- (i) Submission of an undertaking from the State Government toward rectification of deficiencies.
- (ii) Establishment of BSL-2 lab facilities for testing of COVID-19 patients, as soon as possible.

3. The next batch of students in the MBBS course shall be admitted only after permission of the Medical Assessment and Rating Board of the National Medical Commission for renewal as per regulations that would be framed under section 26 and 28 of the NMC Act, 2019.

4. The Government medical colleges (except those located in Union Territory of J&K) shall contribute 15% of MBBS seats for which the renewal of permission is granted for All India Quota.
5. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under NMC Act and regulations made there under.
6. Discrepancies, if any, may be immediately brought to the notice of the Medical Assessment & Rating Board and the State Government.
7. Kindly acknowledge receipt of this letter.
