
I am directed to state that the Board of Governors considered the the Assessment Report (03.07.2020) on the standard of examination and other teaching facilities available for MD(Pathology) qualification for 6 seats in respect of students being trained at Jawaharlal Nehru Medical College, Ajmer granted by Rajasthan University of Health Sciences, Jaipur and decided as under:-

"The Board of Governors considered the assessment report (03.07.2020) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MD(Pathology) qualification for 6 seats granted by Rajasthan University of Health Sciences, Jaipur in respect of students being trained at Jawaharlal Nehru Medical College, Ajmer be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
