Subject: Renewal of recognition of MD(Radiodiagnosis) qualification for 02 seats in respect of students being trained at Jawaharlal Nehru Medical College, Ajmer.

Sir/Madam,

I am directed to state that the Postgraduate Medical Education Board considered the Assessment Report 01.07.2020 together with the recommendations of the PG Expert Group with respect to the standard of examination and other teaching facilities available at Jawaharlal Nehru Medical College, Ajmer for purpose of Renewal of recognition of MD(Radiodiagnosis) qualification for 02 seats granted by Rajasthan University of Health Sciences, Jaipur and decided not to recommend recognition for the above mentioned qualifications due to the following reasons:

1. Deficiency of Associate Professor-1 and Assistant Professor-1.

Admissions done (if any) against these seats i.e. 02 seats, after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with regulations and will not be recognized.

In case you desire to submit a compliance, the same should be received in this office within 30 days from the date of communication of this letter. The compliance should be submitted as a soft copy to pg@mciindia.org along with requisite fee Rs. 1,18,000/- (Note this is including with the 18% of GST) by RTGS/NEFT (the details of the UTR No. should be provided along with the compliance being submitted by you). In case, no compliance is received within this period or compliance is found unsatisfactory, it will result in stoppage of admission.

Please also note that Compliance/ Compliance Verification report should be submitted only in the SAF prescribed for this purpose (available on NMC website i.e. www.nmc.org.in), which should also include the faculty table (entire faculty including those who has been already verified). Information in any other format will not be accepted.
