Dr. G. G. Kaushik Addl. Principal-1st welcomed of all the attended members.

Dr. Veer Bahadur Singh, Principal & Controller addressed Committee members for their stringent efforts in preventing Ragging incidents, both in the Hostel as well as in the College Campus for the year 2019-2020. He explained about the Rules & Regulations and consequences of Ragging as per Hon'ble Supreme Court's, UGC, Rajasthan University of Health Sciences, Jaipur guidelines. Principal also suggested the measures to be taken to curb the incidents of ragging :-

1. The Members should take an active part in the discussion and recommended the measures to prevent ragging both in the Hostels and in the College Campus.
2. All the Wardens & Squad Members must visit the hostels twice daily.
3. To display posters and banners in the College, Hostels, Library, Canteen & other prominent places mentioning the consequences of Ragging.
4. Senior staff members of the Anti Ragging Committee must supervise and invigilate the Hostel and college premises specially after college hours.
5. Suggestion and complaint boxes are to be kept in all the Hostels.
6. Dr. Priyanka, Circle Officer, North Zone, Ajmer recommended that Anti Ragging squad members must make surprise visit to the Hostels as well as in the canteen area of college and hospital premises. She also emphasized upon introductory meeting of freshers and seniors to be organize in the college auditorium.
7. Contact Phone numbers of Wardens and Anti Ragging Committee & Squad to be displayed in the Hostels, Library & Canteen Notice Boards.
8. Dr. Priyanka, Circle Officer, North Zone, Ajmer, stressed about Security arrangements to be strengthened specially during morning & afternoon hours.
9. Dr. Dr. G. G. Kaushik, Addl. Principal-1st has also addressed to all members & apprised that no incident has happened in last three year related to ragging in this college. He hoped that this year also no ragging case must arise.
10. Dr. (Mrs.) Garima Bafna, MOI/c Academic stated that as per the directions of the Medical Council of India, an Undertaking from the Students and parents regarding Anti Ragging Measures is to be taken at the time of joining the college.
11. Dr. R.K Mathur, Chief Warden suggested that, during the anti-ragging vacation (1 August - 14 August) college hostel mess should also remain closed.
12. As per the directions of the Hon'ble Supreme Court, Medical Council of India, New Delhi and University Grant Commission, the consequences of ragging will be informed to every student through respective Head of Department of this college during their classes.
13. Dr. Veer Bahadur Singh, Principal & Controller, has agreed upon the suggestion given by the members regarding the anti ragging measures.
