**NOTICE**

*Ragging is unlawful activity which is liable to serious consequences. Hence all the students of this college are hereby strictly warned not to indulge in ragging of the newly selected / admitted candidates. If any student is found indulging in ragging, will be punished as per the directions of the Hon'ble Supreme Court of India / Guidelines framed by the MCI to curb the menace of ragging in Medical Colleges.*

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.

- Suspension from attending classes and academic privileges.
- Withholding/withdrawing scholarship/fellowship and other benefits.
- Debarring from appearing in any test/examination or other evaluation Process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- Suspension/expulsion from the hostel.
- Cancellation of admission.
- Restitution from the institution for period ranging from 1 to 4 semesters.
- Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.
- Fine of Rs. 25000/- and Rs. 1Lakh.

Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.

**Strict compliance is adhered to.**

Any case of Ragging which comes to the notice of students and their Parents/Guardians or any other person may report promptly on any of the Helplines given below.
