I am directed to state that the Board of Governors at its meeting held on 11.02.2019 considered the Assessment Report (25th June, 2018) on the standard of examination and other teaching facilities available at Jhalawar Medical College, Jhalawar, Rajasthan for purpose of Recognition of MS(OBG) qualification for 2 seats granted by Rajasthan University of Health Sciences, Jaipur and decided as under: -

"The Board of Governors considered the Council Assessor's Report (25th June, 2018) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MS(OBG) qualification for 2 seats granted by Rajasthan University of Health Sciences, Jaipur in respect of students being trained at Jhalawar Medical College, Jhalawar, Rajasthan be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
