NOTIFICATION

Referred to the Government of Rajasthan Notification dated 20-03-2017, The Chairman, PG Medical & Dental Admission/Counseling Board - 2017, The Principal and Controller, S.M.S. Medical College and Attached Hospitals, Jaipur would conduct the single common counseling for admission in PG Medical/Dental (M.D./ M.S./ M.D.S./ Diploma) courses in State of Rajasthan.

For 50% of the State Quota seats (i.e. 25% of the total seats) of Government colleges as well as 50% of the total seats of Private Colleges, the NEET qualified candidates who possess the degree of MBBS from the colleges situated in the State of Rajasthan and all medical officers/medical teachers serving under Government of Rajasthan are eligible to participate and for remaining 50% of the State Quota seats (i.e. 25% of the total seats) of Government colleges, the NEET qualified candidates who possess the degree of MBBS from the University of Rajasthan / Rajasthan University of Health Sciences (Govt. University) are eligible to participate, and for the remaining 50% of the total seats (All India seats) of Private Colleges, all NEET Qualified candidates who possess the degree of MBBS from anywhere are eligible to participate.

All eligible candidates who wish to participate in the counseling process must register themselves through the above websites. A candidate who fails to register shall not be eligible to participate in the counseling.

All candidates are required to deposit non-refundable fee of Rs. 3000/- (Rs. 1500 for SC, ST category of Rajasthan State) and applicable e - Mitra service charges at any e - Mitra center authorized by the Government of Rajasthan or through Internet banking.

Registration and deposition of registration fee through e - Mitra Network will be from 26th March 2017 to 31st March 2017 upto 5:00 p.m. There will not be any further registration after 31.03.2017 (5.00 pm).

For registration, remaining counseling process and all other relevant information (Counseling Schedule / Fees / Surety Bonds / other eligibility / etc.), the candidates are advised to visit www.medicaleducation.rajasthan.gov.in or www.rajprepg2017.org. The seat matrix would be uploaded on 31.03.2017.


The norms for reservation of the State Government of Rajasthan shall be applicable.

No separate information shall be sent to individual candidates regarding the process of admission/counseling.

The allotment of the subject and college shall be made strictly on the basis of merit cum preference and in accordance with the rules and the directions laid down by M.C.I./D.C.I./Hon'ble Supreme Court of India/Hon'ble Rajasthan High Court/ Government of Rajasthan/RUHS.

The candidates are advised to read the instruction booklet, FAQs (Frequently Asked Question) etc. given on the website, very carefully and also keep visiting the websites regularly.

The decision of the P. G. Admission Board 2017 will be final and binding on all the candidates. In case of any dispute the area of Jurisdiction will be Hon'ble Rajasthan High Court only.
