
Minutes of the meeting held under the chairmanship of Principal Secretary Medical Education on 20th June 2012 regarding Virtual Class room in all Medical Colleges and RUHS as per Budget Announcement no. 299 for the year 2012-13

A meeting of Project e-Governance Mission Team (PeMT) was held on **20th June 2012 at 3.30 PM** under the chairmanship of Principal Secretary Medical Education in his chamber regarding approval of proposal submitted by RISL for establishment of Virtual Class room in all Medical Colleges and RUHS as per Budget Announcement no. 299 for the year 2012-13. Directors (Technical) RISL, Dy. Secretary Medical Education, OSD, Medical Education along with Principals of respective Medical Colleges, and representative from NIC were present in the meeting.

The matter of the establishment of Virtual Class room in all Medical Colleges and RUHS was discussed and following decisions were taken:-

1. The project proposal submitted by RISL was approved and it was decided to send it to Do IT&C for subsequent approval of SeMT.
2. It was decided to execute the project through RISL as per provisions under GF&R.
3. Looking to the size of classroom, it was proposed and decided that two (no.) of large LCD/ LED TVs at each site shall be included in the project proposal. The project financials may be revised accordingly.
4. All Principals were directed to appoint a Nodal Officer for monitoring, site preparation and smooth implementation of the project.
5. All Principal Medical Colleges would assess the existing budget provisions for current financial year and will propose for the additional allocation in case it is required.
6. RISL shall provide the appropriate time lines for the implementation of the Budget Announcement.
