
NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules to amend further the Rajasthan Service Rules, 1951 namely : -

1. These rules may be called the Rajasthan Service (Amendment) Rules, 2014.
2. These shall come into force with immediate effect .
3. In the said rules- the existing proviso below rule 8 (inserted vide Notification No.F.1(2)FD/Rules/2006 dated 26-12-2011) shall be substituted by the following, namely:-

"Provided that in the cases of Medical Officer of the Rajasthan Medical & Health service, Senior Demonstrator and Assistant Professor of the Rajasthan Medical Service (Collegiate Branch), who possess MBBS degree and have spent one year in internship, the period of Probation Training shall be one year instead of two years."


