

The Terms of Reference for reviewing the above issue and submitting recommendations are as under:

1. To develop criteria for ranking of hospitals attached to Govt Medical Colleges based on qualitative indicators.
2. To suggest a mechanism for ranking of hospitals attached to Govt Medical Colleges.

(The above Advisory Committee shall be empowered to invite any expert as Special Invitee to facilitate its function / discussions.) The Committee shall submit its report to the State Government within 15 days.
