post graduate student and his surety covenant with the Government as

1. Candidates who are selecting Government Colleges for the post graduate courses shall serve the Government for a minimum period of five years after completion of the course, if Government desires.
2. That in case the post graduate students, who fails to fulfil the above conditions, the surety of the post graduate student shall be jointly and separately liable for penalty of Rs. 15,00,000/- for degree and Rs. 5,00,000/- for diploma course after completion of the course as per this Bond/Undertaking.
