2. Duties & responsibilities shall be assigned by the Head of the Department of concerned specialty, including casualty services.
3. 07 Casual Leave shall be granted in initial six months period and 08 Casual Leave shall be granted for next six months after obtaining the service extension order by undersigned and for any other type of additional leaves, no stipend will be paid.
4. Junior Resident will not be provided any Govt. accommodation.

8. The Junior Resident is liable to be terminated if the work and conduct are reported unsatisfactory.

14. He/She must submit his/her joining report to the undersigned within 07 days from the issue of the this order, failing which the selection order will automatically cancelled.

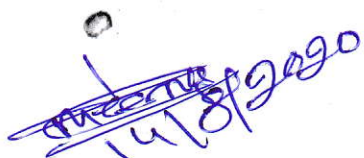
