1. As per govt letter no. . P.7(54) (252)(02) DME/Acad/2021-Part dated 30.11.2021 vide this office order no. F.2/Estt./MC/JU/2021/25889-95 dated 01.12.2021 the post of Junior Resident will be valid from 01.12.2021 to 28.02.2022 (**3 Months**) or untill completion of NEET PG counseling whichever is earlier.
2. Duties & responsibilities shall be assigned by the Head of the Department of concerned specialty, including casualty services.
3. Junior Resident will not be provided any Govt. accommodation.
4. The Selection will not create any Right for further study in the concerned specialty.
5. If the Junior Resident remains absent more than 7 days in the department without prior permission from concern authority, will be terminated/cancelled from their services without any prior notice.
6. If the Junior Resident leaves the country without prior permission from concern authority, will be terminated/cancelled from their services without any notice.
7. The Junior Resident is liable to be terminated if the work and conduct are reported unsatisfactory.
8. Selected candidate will not take part in any type of strike, if they will found in strike activities; their services will be terminated/ cancelled without any notice.
9. He/She must submit two character certificates from two separate Gazetted officers, medical Fitness certificate from competent authority at the time of joining.
10. In case of in-service/Government employee, Relieving order and No Objection Certificate from competent authority must be submitted by the candidate at the time of joining.
11. Period of absence will not be extended.
12. All the selected candidates have to join within 3 days of issuing this order.
