All the following terms and conditions will applicable on above mentioned selected candidates:-

1. This appointment as Junior Resident is done for the period of six months from the date of joining. Subsequently, undersigned can extend the period of this service as Junior Resident for next maximum six month, after obtaining the recommendation and satisfactory performance report from concerned

- HOD, failing which the service as Junior Resident will be treated as automatically terminated.
2. Duties & responsibilities shall be assigned by the Head of the Department of concerned specialty, including casualty services.
 3. 07 Casual Leave shall be granted in initial six months period and 08 Casual Leave shall be granted for next six months after obtaining the service extension order by undersigned and for any other type of additional leaves, no stipend will be paid.
 4. Junior Resident will not be provided any Govt. accommodation.
 5. The Selection will not create any Right for further study in the concerned specialty.
 6. If the Junior Resident remains absent more than 7 days in the department without prior permission from concern authority, will be terminated/cancelled from their services without any prior notice.
 7. If the Junior Resident leaves the country without prior permission from concern authority, will be terminated/cancelled from their services without any notice.
 8. The Junior Resident is liable to be terminated if the work and conduct are reported unsatisfactory.
 9. Selected candidate will not take part in any type of strike, if they will found in strike activities; their services will be terminated/ cancelled without any notice.
 10. He/She must submit two character certificates from two separate Gazetted officers, medical Fitness certificate from competent authority and all original documents as mentioned in application form at the time of joining.
 11. In case of inservice/Goverment employee, Relieving order and No Objection Certificate from competent authority must be submitted by the candidate at the time of joining.
 12. Period of absence will not be extended.
 13. In case, a junior resident wants to resign from the post, He/She has to give prior one month notice or will deposit one month stipend & D.A as admissible at that time.
 14. The Junior Resident have to join within 7 ~~days~~ working days of issuing this order
