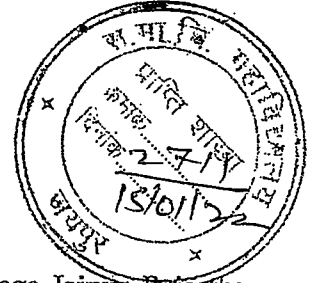

In case false/wrong declaration or fabricated documents have been used for procuring permission of the MARB and any misconduct is brought to the notice of National Medical Commission (NMC) or found during surprise assessment at any stage during the current academic year, your institution is liable, not to be considered for recognition of the degree. It is mandatory for the government medical colleges to contribute 15% of MBBS seats and 50% of Post Graduate Broad Specialities (MD/MS) for All India Quota respectively, to MCC of DGHS for conduction of counselling as per the Directions of the Hon'ble Supreme Court.


