

Sub.-: Regarding purchase of books for RRC Library.

We are interested in purchase of PMR subject related books for our library as per G.O.C. norms. The other terms & Conditions are as follows:-

TERMS & CONDITIONS

PURCHASE OF BOOKS FOR THE YEAR 2021-2022

1. The Vendor should be a member of the authorized supplier by G.O.C.
2. The supplier will have to supply the books within a month placing the order. In case of the supplier needs more time for supply, he or she should get such permission from Director RRC in writing based on genuine reason and mutual understanding.
3. Supplier must submit the Experience Certificate of supply of books atleast Two years of any Two Govt. Medical College Institutes of satisfactory services.
4. If the ordered books are not supplied as required "Non-availability Certificate" of the ordered books is not furnished within one week by concern supplier, 2.5 to 10 % penalty of entire order will be charged on the cost of non supplied books.
5. The prices charged as per the publishers invoice (Publishers/Importers/Distributors) and latest catalogue.
6. The latest editions of books should be supplied by the supplier and there should be no remaindered titles.
7. The books supplied against the order should to be checked against defects in collation, binding and condition of accompanying material Viz, CD's etc. and for other physical conditions. If any defects are detected later, the defective books will be replaced by us free of cost, at the destination of supply.



8. A copy of publisher's invoice/Catalogue/Price list as a price proof without cuttings.

9. Conversion rates G.O.C. rate should be charged at the time of supply.

10 Quote rate of discount give by you.

11. Supplier will submit in agreement /affidavit on non-judicial stamp paper of Rs. 500/- as per discount rate approved after negotiation duly attested by notary public.

12 It will be the responsibility of the approved supplier to ensure regular and timely supply of books by publishers/Distributors/Exclusive agents on the following address:-
