शैक्षिक सत्र 2020-21 में जारी आरटीई दिशा-निर्देशों के संबंध में विभिन्न गैर सरकारी विद्यालयों से प्राप्त सामान्यतया पूछे जाने वाले प्रश्नों के सम्बन्ध में निम्नानुसार स्पष्टीकरण जारी किये जाते हैं:-

S.NO	QUESTIONS	ANSWERS
1	That the guidelines have been Issued in first week of July, whereas we have filled all seats of class-1 for the current session that is 2020-21 In April itself, as the session in our school already started in the month of April, that is on 1 st April 2020.Thus there is no vacancy in class-1 as on date.	As per the RTE guidelines effective from the session 2020-21, it is clear that 25 percent seats of class-1 shall be reserved for RTE admissions.
2	That at PP-5 level there are 24 students who applied for admission under RTE at PP-4 level in the session 2018-19 these students are now promoted to class-1. Will they be considered eligible for free education under RTE Act in class-1 or will they have to apply again.	Yes, they will be considered for free education in class-1 and the seats (25 percent) will be counted including these ...X... number of students and after including them if the 25 percent seats of class-1 (Including all seats) are still not filled, then the school has to take new admissions class-1 according to the ratio of 1:3 under RTE Act. As an example, if you are taking admission on 120 seats in class-1 then 30 students must be admitted in class-1 under RTE guidelines effective from the session 2020-21. If 24 students have already been promoted to class-1 from PP5+ then 6 new students must be admitted in class-1 according to the ratio of 1:3.
3	That at PP-4 level some students sought admission under RTE in the session 2019-20 these students have now been promoted to PP-5 level. Will these students continue availing free education under RTE Act.	Yes, they will be considered under RTE Act, for this session.
4	We have always reserved 25% seats for RTE in pre primary section of our school at PP-4 level and this year also we did the same. In this situation our seats in Pre Primary will remain vacant.	As per the RTE new guidelines effective from the session 2020-21, it is clear that RTE admissions and reimbursements will be considered from class 1 st only.
