4	Other Allowances Compensatory Allowances, City Allowances, House rent Allowances	Compensatory (City Allowances, HRA shall be admissible according to the rules of the parent Govt. or borrowing authority whichever more beneficial.)
5	Medical attendance	Medical Concession shall be admissible according to the rules of borrowing Govt./Foreign employer or under the rules of parent Govt./ Council whichever is beneficial.
